- Updates on requirement for SHAC from the Education Code Section 28 (d-1) and (d-2):

Post notice of the date, hour, place and subject of the meeting on a bulletin board in the central administrative office of each campus in the school district 72 hours before the meeting Notice is posted on the district's internet website.

Prepare and maintain minutes of the meeting that state the subject and content of each deliberation and each vote, order, decision, or other action taken by the council during the meeting.

Make an audio or video recording of the meeting.

Not later than the 10th day after the meeting, submit the minutes and audio or video recording of the meeting to the district.

SHAC makes recommendations Per Texas Education Code 28 health advice to the School Board. The school is not allowed to state conscientious decisions about exemptions by parents and staff on COVID information on their student or themselves.

Sexual Education Program was discussed for Middle and High School Students

Abstinence Program (Aim for Success) – 10th graders for 4 days normally in April in English class for 40 minutes in a week
